Brief History

Guy A. Carlton (1837-1900) began life in Maine and came with his family to Bloomington in 1854. He wed Emily Little in 1859. After a variety of adventures and occupations and war service, he opened a livery stable at Washington and East in Bloomington. In 1889, he built a stable at Douglas and East. A few years later he became part of the undertaking firm Carlton and Beck. Carlton was also active in GAR, having served as a first lieutenant in the 94th Illinois Volunteer Infantry. The Carltons had three children who reached adulthood: Ada Carlton (1860-1920), Guy Carlton (1877-1944) and Clara --Mrs. George—Smith (1867-1914).

Ada Carlton never married and was deeply involved in the Woman's Relief Corps and the Woman's Club. During WWI, she was known as a tireless volunteer with the Red Cross Canteen serving soldiers.

Guy A. Carlton (1877-1944) first became intrigued by electrical work in 1885 when the City of Bloomington had their electrical supply department in the rear of the Carlton barn at Washington and East. That same year his Uncle Sam Carlton and Sam's son Ben opened the first electric light plant in Bloomington. Guy began installing electric door bells and electric gas lights and later opened his own electric business in his father's new barn. In 1895, he partnered with John L. Lemons. Lemons exited in 1897, with Carlton then controlling the entire business. Carlton moved to the Hoblit Building at 526 North Main in 1901. By 1922, he purchased the building and changed its name to the Carlton Building. He rented space in the building to a variety of businesses including Brown's Business College.

Under his leadership, the firm installed the first ornamental street lights in Bloomington – on Main Street. They also provided the power plant for the McLean County Poor Farm as well as serving many businesses, homes, churches, and schools. Carlton was highly active in Rotary Club for many years.

Guy married Elizabeth Foley (1878-1956) and they raised two daughters and a son – a third generation of Guy A Carlton (1912-96).

Upon her death, Elizabeth Carlton left the electrical business to son Guy. She stipulated that the store building be sold and the proceeds split amongst her three children.

Guy (1912-96) attended Illinois Wesleyan and University of Illinois School of Engineering. He became active in the business and assumed leadership when his father's health faltered in the 1940s. Following a 1973 fire in the adjacent Knights of Columbus Hall, the Carlton Electric concern was so fire and water damaged that the business was closed. Two months later Carlton was working for Springfield Electric's Lighting Center in Bloomington.

Guy (1912-96) wed Edith Mueller (1914-2006). She graduated Bloomington High School and earned a BS in Home Economics at Illinois Wesleyan University in 1936. Edith co-owned and operated Carlton Electric.

Scope
