# **Biographical Information**

Warren Craig was born Dec. 24, 1920, in Fairbury, Illinois, to Will and Georgia Craig. In 1946 he married Joybelle Dickey, born January 30, 1922. Warren died in May 26, 2015, and Joybelle died December 19, 2015. Their children are Barbara Craig-Schniepp, Shirley Craig, Linda (Craig) Reed, and Paul Craig.

Warren Craig served in the U.S. Army during World War II. After the war he graduated from Illinois State Normal University and earned a master's degree from the University of Illinois. He taught speech, English, reading, and drama in Lincoln, Bloomington, and Normal, serving as Unit 5's first Reading Coordinator. Warren operated Craig Canvas Service for over 50 years. An active member of the North Bridge Baptist Church of Normal, he held many church offices and was part of the American Baptist Men's disaster relief team. He formed the first neighborhood association in Normal and assisted other neighborhoods to do the same.

Joybelle (Joy) Craig graduated from Illinois State Normal University in 1940 and began teaching business courses in Clinton. When her children were older, she returned to part-time secretarial work and then became a valued volunteer with the McLean County Historical Society. She also participated in the Woman's Missionary Society, taught Sunday school and held several American Baptist Association regional offices.

The Craigs became the first off-campus ISU student housing providers to deliberately integrate their rented rooms. In later decades, Joy and Warren hosted international students and foreign exchange teachers in their home. As a result, they traveled to Japan and Germany as invited guests of those students.

# **Scope Note**

This collection covers day-to-day events in Warren F. Craig's life starting in the late 1930s to 2015 documented in ledger books, which include his time in the service (1942-46) as well as a scrapbook, notebooks and 3 ledgers of expenses. The scrapbook contains photos and newspaper articles of Craig's time as a high school speech teacher and speech coach. He was also technical director of several Bloomington High School plays.

The collection includes a one-year diary written by Joybelle Craig and 4 spiral notebooks in which she wrote every day from 1982 through March, 2001. The entries include everything from weather and grocery store trips to sponsoring foreign students and volunteer work as well as her comments about whatever happened that day.

The miscellaneous file includes a business card for Craig Canvas Service, additional newspaper articles with photos and the gift agreement listing donation contents.

# Loose Items

## Ledger 1:

The first ledger book begins January 1938, address at Fairbury, Illinois, with entries for all money spent from ice cream and gloves to church. There are credits for a paper route and

other small jobs. In 1941 there are deposits from the Ben Franklin Store, and by May 28, 1941, there are Fuller Brush Com. deposits. The first entry for September 1941 showed Craig had moved to Normal and enrolled at I.S.N.U. This ledger ends with the July 2, 1942 entry.

## Ledger 2:

The second ledger book begins on July 11, 1942, address at Normal, Illinois, and includes entries for bus fare, dates, and church. The deposits were for work at Kinney's. The September 24, 1942, entry address changed to U. S. Army. The February 13, 1943, address shows the army address as in the Aleutians. Craig started buying Series E War Bonds in July 1943; he also set money home.

## Ledger 3:

The third ledger book begin January 1, 1958, no address. The title names on the Book are Joybelle O. Craig and Warren F. Craig, 1958 – 1980. The entries include house payments, clothing, babysitting, utilities, and household goods.

#### Diary

The Five-Year Diary was written by Joybelle in 1976. It is a day-to-day account of the weather and what she did for the day. A remembrance card from Calvert & Metzler Memorial Home for Joybelle (deceased December 19, 2015) was in the back of the diary.

#### **Spiral Notebook 1:**

The first notebook is labeled Joybelle, 1982. The daily entries include weather, doctor and dental appointments, along with projects that she and others were pursuing. There were also entries for when and where they dined out. The last entry is September 19, 1989.

#### **Spiral Notebook 2:**

The second notebook begins September 20, 1989, with the same format as the first with daily weather and grocery shopping. She was taking German classes as they were sponsoring a student from Germany. She also was attending husband's plays and speech contests. The last entry is May 12, 1992.

#### **Spiral Notebook 3:**

The third notebook begins on May 13, 1992 with the weather. Joybelle was involved in many community organizations, charities of her church, and clubs. She was also a volunteer at the McLean County Museum of History. She went to many plays at ISU and IWU as well as movies. The last entry is October 13, 1996.

### **Spiral Notebook 4:**

The fourth notebook begins on October 16, 1996, with a description of surgery. She was in St. Joseph's Hospital 5 days resulting in a walker and physical therapy. The entries continue with daily weather, social, and community engagements. She also mentioned researching for the Cemetery Walk. Last entry is March 15, 2001.

#### **Spiral Notebook 5:**

The fourth notebook begins on March 16, 2001 and continues through Dec 2010.
