Brief History

Levi C. Dillingham was born on May 29, 1849 in Morrow, Ohio. He came to Bloomington by wagon from Chicago in 1872. In that year, he opened M.R. Tuttle and Company with two partners. The company had many wagons which were used to distribute supplies throughout the nation and to collect farm produce that was brought back to Bloomington to stock local stores. The company was first located on South Main Street in Bloomington and then moved to a building at Center and Monroe Streets.

On March 27, 1877, Levi married Dora J. Scott who was born in Greensboro, Maryland on June 19, 1858. Levi and Dora had six children, four of whom died in infancy. Two children lived to adulthood, Delmar Charles and Samuel Bert Dillingham. Levi died on August 29, 1934 in Bloomington. Dora died on March 31, 1947 in Peoria.

Samuel Bert Dillingham, who generally went as Bert, was born on May 25, 1886 in Bloomington. He married Gertrude Fritz on April 2, 1910 in Enid, Oklahoma where he resided for a couple of years before moving back to Bloomington. Bert and Gertrude had one son, L. Everett Dillingham, who generally went as Everett and was born on August 19, 1914. Bert Dillingham worked for a number of years as an operator at the Castle Theater in Bloomington. Bert died at the home of his parents, Levi and Dora, in Bloomington on December 21, 1916.

Bert's son, Everett Dillingham, worked for Illinois Power Company, for over 40 years retiring in 1976. He served in the U.S. Navy during World War II. He was a member of the Moose, Elk, and Masonic lodges, the Scottish Rite Bodies, and the American Legion in Bloomington. He married Barbara B. Guenther on August 30, 1941. She died on November 2, 2004. Everett and Barbara had one daughter, Susan, and one son, Sam. As of 2007, both Susan and Sam were still living. Everett died on January 11, 2007 in Roseville, California, which is where his daughter, Susan, was living. He was buried in Bloomington with military rites.

Levi and Dora's other son and Bert's brother, Delmar Charles, was born on February 21, 1878, in Bloomington. On July 25, 1900 he married Clara Strohmeier. Clara was born on January 7, 1880 in Petersburg. Clara had two sisters, Matilda (Tillie) and Kate, and one brother, Fred. Kate married Charles Behnke. Delmar and Clara had one daughter, Mildred Dillingham, who was born on January 28, 1905.

Delmar and Clara moved to Clinton, Illinois in 1903. At that time, Delmar and his father, Levi, opened a clothing store in Clinton. When Levi retired, Delmar became the sole owner of the store. He was still running the store at the time of his death. While living in Clinton, Delmar was a member of Rotary Club, a president of the Clinton Commercial Club before it became the Association of Commerce, the DeWitt lodge No. 94, and the Christian Church.

Delmar and Clara's daughter, Mildred, attended Clinton High School from 1918 to 1922, where she generally received excellent marks. She then attended Rockford College from 1922 to 1924, and then was admitted to the University of Illinois Library School in 1924. Upon graduation, she worked as a librarian for the University of Illinois, Ohio State University and Rockford College. She also worked as a personnel director at Marshall Fields in Chicago, in the medical records

department at Mennonite Hospital, and as a clerk stenographer in the Department of Registration and Education for the State of Illinois. She married Earl Thomas on March 18, 1928. She then married Stephen B. Hazle in 1955. She had no children through either marriage.

Scope

The Dillingham collection consists both of public and private materials from a multi-generational family that lived much of their lives in the Bloomington-Normal area. A majority of the collection consists of correspondence between Mildred and her mother, Clara, from 1937 to 1949. The collection is in one large box and one small box. There are 38 folders in the boxes and one post card album. Folder one contains copies of family members' obituaries and newspaper stories on family members.
