Historical Sketch

George W. Funk was the firstborn son of the Hon. Isaac Funk, Sr. and Cassandra Sharp, founders and pioneers of Funk's Grove. He was born May 14, 1827 in Funk's Grove. At the time of his father's first appearance in Funk's Grove, in 1824, the prairie of the "Old Northwest" (as it was then known) was sparsely populated. Population totals for this area in 1820 were estimated at less than two persons per square mile. George was described as being 5' 10 $\frac{1}{2}$ " in height and about 200 pounds in weight with grey eyes and black hair.

His education began at the age of seven and he travelled one and a half miles to the log schoolhouse in Funk's Grove. After the age of ten, George only attended school during the winter as he worked the family farm during the other seasons until he was eighteen. He attended school in this way until age twenty-one.

George was assisting his father on the farmstead at an early age, and in time trained his nine younger siblings, earning from them the nickname "The General." He was 16 when he made his first livestock drive to Chicago. He was considered an excellent business man and handled his father's affairs during the final decade of Isaac's life.

On January 29, 1868 George married Susan Pumpnelly, a native of Ohio, who died less than a year later, 6 days after giving birth to their first child Isaac George. George remarried on May 30, 1876 to Rosealtha Fitzwilliam, also a native of Ohio. Three children were born from this union, Madeline, William, and Julius. They had a home in Bloomington at 401 East Washington Street as well as their farmhouse in Funk's Grove.

As busy as he was with farming, George found time to pursue his interest in banking at the First National Bank of Bloomington and in serving the local government in Mt. Hope Township as a member of the Board of Supervisors. Though he identified with the old Whig party in his early years he was elected as a Republican member of the lower house of the Legislature for the 1871-72 term. In 1879 he was described as a stock-dealer and owned 3,200 acres in McLean County and 4,400 acres by 1887.

George was known to frequent Cash Harlan's Cigar Store in his later years, gathering with other elders to discuss agriculture and politics. He died July 5, 1911.
