Brief History

A group of local Germans met on 24 April 1884 in the schoolhouse of the German-American School Assn at Front & West (now Roosevelt) Streets in Bloomington. To create the German Evangelical United Friedens Church, they adopted a constitution and called A. Aronet of Dewey, IL, as pastor. Initially the schoolhouse served for meetings and worship services. In Aug 1884, they purchased a building site at Front and Lee Streets. Lacking enough funding to build a stately church edifice, they instead erected a new schoolhouse which also

would be used for worship and an upstairs parsonage. Later, in September 1902, they finally dedicated a new church building.

The Friedens Church remained independent until 1916, when it joined the Evangelical Synod of North America. In the late 1930s, despite the Depression, the congregation paid off their debts. They also discontinued use of German language.

The Evangelical Synod in North American merged with the Reformed Church in US in 1934 to become the Evangelical and Reformed Church. The resulting church merged again in 1957, this time with the Congregational Christian Church, to become the United Church of Christ.

Locally, the Friedens Evangelical Church adopted a new name and a new constitution in about the late 1940s, becoming St. Luke's Evangelical and Reformed Church.

In 1968-69, St. Luke United Church of Christ (as they were now named) purchased nearly two acres at the corner of Oakland and Mercer, intending to construct a new church edifice some day.

And, in Sept 1975, following a couple years of discussion, the St. Luke United Church of Christ merged with Union Presbyterian Church to become St. Luke Union Church of Bloomington. They moved to a new location on East Washington Street about 1976.
