Brief History

Daniel Henry Iseminger (1837-1911) was born the son of Daniel & Sarah (Wile) Iseminger in Ohio. He wed Mary Susan Slagel in 1872, lived in Heyworth area, and the couple moved to South Clayton Street in Bloomington in 1876 to spend the rest of the lives. Daniel was a carriage painter by trade and, as an inventor, held several patents.

Mary Susan Slagel (1872-1938) was born in West Virginia and came to Coles County IL at age five weeks. She moved with her family to Heyworth at age 2, where she eventfully met and wed Daniel Henry Iseminger.

Both were members of the First Christian Church in Bloomington. The couple reared two children: daughter Lulu B. and son Floyd.

Floyd (1879-1980) was born and lived his entire life in Bloomington. He quit high school out of lack of interest in what they were teaching. He worked on steam engine for a laundry, then as a bicycle repairman. In 1905, Floyd opened the first Ford auto dealership in McLean County. In 1915, company politics led to him losing his Ford dealership contract. He then sold Hupmobiles until 1919. After that, he repaired cameras for a living.

In 1907, Floyd married Emily Ann Blair; she died 1939. After being widowed for 23 years, he married Grace Blair in 1982 when he was age 83.

Scope
