Collection Information

Historical Sketch

Ethel Pearle Smith (June 8, 1892 – July 12, 1952) married Albert Green Jones (August 12, 1887 – July 3, 1959) on September 10, 1910. Albert was the son of John Henry Jones and Sarah Davis; Pearle was the daughter of Martin and Elsie Smith and was born in Clinton, Illinois. They had four children: Forrest T., born ca. 1913, Elsie Marie born ca. 1917, Carl C. born ca. 1922, and Ernest Martin born May 3, 1924. They divorced March 5, 1945. Albert's second wife was Elta Avalon Campbell; they married ca. 1945/46.

Albert was a machinist and worked for the Alton Railroad company, retiring in 1946.

According to the Bloomington-Normal Directory Ethel Pearle Jones lived at 210 Albert Street in 1943/44, 1307 N. Roosevelt Street in 1946 and 1304 N. Oak Street from 1951 until her death in 1952.

Scope and Content Note

This collection contains the prose, poetry and plays written by Ethel Pearle Smith Jones, and some biographical information. The prose includes short stories, household hints, and some religious items. The poems include single poems and a manuscript for a small book of poetry. This collection also includes divorce and mortgage documents, the school records of Ernest Jones and his wife Olive Douglas as well as genealogical information on the Smith family.
