## **Collection Information**

# **Brief History**

Ladies Auxiliary to Barracks #1097 of the Veterans of World War I of the United States.

The Veterans of World War I organization was created in 1949, first in Ohio, and then, in 1954, in Illinois. In 1958, the 85th Congress of the United Stated chartered the Veterans of WWI. That same year, the Ladies Auxiliary to #1097 based in Bloomington was formed with thirty-five charter members.

Most of the members were wives of veterans, so by 1958 the group was aging. After a period of growth, membership gradually dwindled as members moved away, became less mobile, or died.

The Auxiliary hierarchy included: National Regional (IL, IN, KY, MI, OH, and TN in Region 6) Department (state of Illinois) District (#10 included the McLean unit and northern Illinois units) Auxiliary (local unit – such as for McLean County Barracks #1097)

Jennie Mae Taylor joined the Auxiliary in 1982 but had attended some meetings with her mother in earlier years. She served in various officer roles in the local auxiliary. She also served in various roles at Department including chaplain in the late 1980s and in the 1990s. She was also a trustee for the Ladies Auxiliary to the Veterans of Foreign Wars (VFW) Post 454 in the 1990s.

# **Scope Note**

This collection includes a selection of materials preserved by Jennie Mae Taylor of Bloomington primarily from the Auxiliary and the Department such as auxiliary minutes, membership lists, financial records, installation certificates, newsclippings, correspondence and photos, department convention programs, general orders, and officers' annual reports.

A few of her materials from the VFW Ladies Auxiliary to Post #454 are also included.
