Brief History

Timeline:

- 1900 Bloomington Business Men's Association formed.
- 1901 Bloomington Business Men's Association incorporated.
- 1912 Name changed to Commercial Club of Bloomington.
- 1922 Name changed to Association of Commerce of Bloomington.
- 1968 Association of Commerce of Bloomington and the Normal Chamber of Commerce merge to form the Association of Commerce and Industry of McLean County. The ACI's scope of activities becomes county-wide.
- 1984 Name changed to McLean County Chamber of Commerce.

Originally formed in 1900, this association of businessmen wanted to improve the community after it had been ravaged by a fire that almost destroyed half of downtown Bloomington. Nearly every major business was destroyed and most were not adequately insured, so they suffered

financially as well. About 200 businessmen met to discuss the city's future and 89 of those men formed the first Bloomington Business Men's Association. They brought businesses and new jobs to the city which helped Bloomington rise from the ashes and become a prominent center of commerce in downstate Illinois. As the association grew, the city started to expand in size and commerce partly due to the influence of the Chamber of Commerce.

The organization held festivals in Bloomington to foster interest in building businesses in the city and strengthen connections with the association. Railroad, electric, and other companies sought opportunity to build in Bloomington and the association helped them achieve this through its influence and strength. The association even fought to keep Illinois Wesleyan University in the McLean County area during the early 1900's when the school could no longer hire staff and was planning to relocate to Springfield. The association was willing to pay for the expansion and reestablished Wesleyan which led the school to become one of the best small Midwestern colleges of its time.

During the Great Depression, the association had to fight even harder for progress. They created public work projects, unemployment committees, and even raised funds to provide relief to families in need. It was the most difficult time for the association because members were leaving due to their businesses going under during the years that followed the stock market crash. Despite this, the association carried on and grew exponentially in the years that followed the World War II. They decided that Bloomington needed to revitalize almost every aspect of the city for the future: roads needed to be resurfaced, buildings repaired, the public schools were far behind the times compared to other schools, and the sewers were inadequate at best.

The association continued to expand and grow much as Bloomington did in the following decades. In the 1970's when it was known as the Association of Commerce and Industry in McLean County, Bernard Wall was the president of the association and he petitioned for the unification of the Bloomington and Normal – albeit unsucessfully. The association also began to expand to other counties across Central Illinois in search of new potential business opportunities and gains. Expanding economic development started to become a trademark characteristic of the association during this time. Labor unions under John Penn also joined the Chamber of Commerce. In doing so, unions and business elites worked together to organize a collective body that not only wanted to provide the city with new business opportunities, but also provide workers with safe and reliable jobs for the growing county.
