Brief History

Born and raised in Chicago, Carol Anne Rylander demonstrated an early interest in art, starting classes at Chicago's Art Institute at age nine and continuing this interest through her time at Austin High School. However, she chose to major in Chemistry while becoming a student leader at DePauw University in Greencastle, IN (1948-52). For her M.A. at DePauw (1954), she pursued her growing interest in human behavior by studying sociology and social psychology.

After a summer as a counselor at a camp for youngsters from low income families, she moved to Normal to become a dorm director and teach a course in social psychology at Illinois State Normal University. At a social for new faculty, she met a young historian named Earl Reitan who specialized in eighteenth century British history. The two married in 1956 and reared two children, Julia and Thomas.

Reitan taught sociology part time at Illinois Wesleyan University, Illinois State University, and Lincoln College at various times over the next two decades. Over an eight year period (1967-1975) she became a full faculty member at Eureka College's social science department.

In 1964, Reitan plunged into civic life by serving as co-campaign manager for candidates for Normal's mayor and town council. She followed that with a stint on the Town of Normal Planning Commission in 1964-66 and became active in the League of Women Voters starting in 1965. She was appointed to fill a position on the Normal Library Board in 1970 and became Board secretary. She promoted a plan to obtain funding for a new library building from the Normal Town Council.

Reitan ran for mayor of Normal in 1972, edging out a well-known Normal businessman and council member by a slim 48-vote margin. During her four year term, she successfully urged the council to increase meetings to twice a month; hold all meetings open to the press and public; build a city hall by razing old buildings in downtown Normal; establish a new Amtrak station downtown; complete the new Library building; change paving of major streets to concrete rather than asphalt; and establish administrative policies to implement the recently voted city manager type of government. At this time, relatively few women were elected officials, prompting much attention to the "lady mayor."

When she threw her hat into the ring for a state Senate seat in 1975, the local newspaper noted, "Mrs. Reitan enjoys public life and seems to thrive on public debate." She ran against incumbent Republican Senator Harber Hall. After initially considering running as an independent, she opted to run as a Democrat in a traditionally Republican district. Reitan's grassroots campaign involved a multitude of appearances in Bicentennial parades, speaking engagements, coffees and dinners at volunteers' homes, etc. throughout the six-county 44th District. A last-minute newspaper advertising campaign by her

opponent's colleague falsely attacked Reitan for nearly bankrupting Normal during her mayorship. *The Pantagraph* refused to publish the advertisement but it appeared in weekly papers throughout the district. This created a flurry of responses from Reitan and the Town of Normal. Reitan carried McLean County but lost narrowly in the overall vote.

From 1977-79, Reitan partnered with five other local women (Luellen Laurenti, Kay Stults, Sandy Rives, Betsy Carr, and Harriett O'Daffer) in a "consulting and marketing company" called CAMCO. The firm's partners had been Reitan campaign workers together in 1975. They developed logos, planned special events for clients, etc.

In 1978, Reitan again pursued the 44th District Illinois Senate seat. This time Republicans fielded farmer and Farm Bureau president John Maitland as their candidate. After an active campaign on both sides, Maitland won convincingly.

From 1979-82, Reitan designed five solar homes in McLean County, working with contractors to complete them. She partnered with local developer Vernon Prenzler on plans for "Scandia Subdivision" of passive solar homes in Normal. Although approved by the Normal Council, the subdivision plans were scrapped when the housing market collapsed in 1980-81.

Reitan became executive director/CEO of Mid Central Community Action, Inc., serving from 1981-95. During this time, the agency took over the local countering domestic violence program and restored a large Victorian house to use as a new shelter for abused women and their children (known as the Neville House). The agency pursued a variety of services for lower income residents focusing on emergency assistance, self-sufficiency, affordable housing, energy assistance and weatherizing homes, recycling and more. Ecology Action Center developed as an offshoot.

Before leaving Community Action, Reitan co-founded Collaborative Solutions Institute with Cheryl Gaines, Kathy Tornquist, and Deborah Sudduth. Reitan served as president/CEO from 1993-2004 continuing as a mediator and a Board member. This not-for-profit professional practice provides counseling and mediation for at-risk youth and adults with a variety of personal challenges.

Along with these major pursuits, Reitan engaged in a series of other community activities. She was a founding member of the Heartland Theatre Company, First Night (a community New Year's Eve celebration), Habitat for Humanity of McLean County, Community Foundation of McLean County, and several other organizations. She served on the McLean County Regional Planning Commission (1979-80 and 1993-96); chaired the Town of Normal 2015 Twenty-five Year Planning Committee (1989-90); co-chaired the Alternatives to Jail Committee (2000 onward), and many other committees. And, Reitan continued her love affair with campaigning as she worked on the campaigns of Sherrie Auth for McLean County Treasurer (2002); Tari Renner for 11th District Congressman (2004); David Gill for 15th District Congressman (2010) and others.

Scope Note

This collection includes a selection of materials donated by Carol A. Reitan largely involving her civic life as mayor and her two senatorial campaigns plus service at Community Action. Materials include campaign literature, letters, plans, and volunteer instructions; newspaper articles; public speaking notes; civic awards; etc.
