Brief History

Madame **Minnie Saltzman Stevens** (March 1873-January 25,1950) was born in Bloomington, Illinois, the daughter of John Michael Saltzman, a Union Civil War veteran, and Wilhelmina Benecke Saltzman. From childhood she had a strong desire to sing and perform before an audience. Her father died when Minnie was four, leaving the family in financial straits. As a teenager Minnie worked for a time in the folding room of *The Daily Pantagraph*, while her brother Henry was stage manager at the Grand Opera House. Holding on to her dream, she joined the Amateur Musical Club in 1889, saved money to purchase a

piano, began piano lessons, and joined a church choir to improve her voice and to earn money for music instruction. In an autograph book from the 1890's Minnie noted "took my first vocal lesson Wednesday A.M. November 20, 1895, from Miss Stevick in Bloomington, Ill."

Minnie Saltzman became the second wife of Bloomington druggist **Dr. Alexander Steven**s on August 23, 1899. Dr. Stevens supported her desire for better voice training and sent her abroad "to study and see if any one over there understands and recognizes what you know you have in you." (See letter from Minnie to Edith Beyer dated Nov. 1 1936 in Archives vertical file.)

Minnie went to France in 1904 and for four years studied with **Jean de Reske**, a famous opera tenor, who, during a lesson, pushed her to sing "Twilight of the Gods" by Richard Wagner. Minnie found it perfectly suited to her contralto voice. In 1908, the manager of Covent Garden heard Saltzman Stevens sing and offered her a chance to perform in London. She accepted, joining the Covent Garden Opera Company for the 1908 season, and made an acclaimed debut, especially impressing Wagner's son Siegfried, with whom she was later associated.

In the following years Minnie became well-known as a Wagnerian soprano, and toured Europe, as well as America in 1910. She performed at least once in Bloomington at the Chatterton Opera House. At the outbreak of **World War I** she chose to wait out the hostilities in Italy, living first in Florence and then in Milan, which became her "temporary" residence for the remainder of her life. Her husband died on May 26, 1921, at her mother's home in Bloomington and was buried in Evergreen Cemetery. The Stevens' had no children.

According to a letter by **Joseph F. Bohrer**, Minnie's attorney, dated October 26, 1948, a throat ailment developed around 1914 which put an end to Minnie's musical career. She waited in Italy, hoping that her voice would return. When **World War II** came she received a protective passport from the Swiss government in order to stay in Italy. Minnie's letters to Bohrer and other close friends express her desire to return to her native United States, thereby ending her "self-imposed exile", but circumstances prevented this. Minnie Saltzman Stevens died peacefully in her sleep in Milan on January 15, 1950, following a heart attack. Her body was shipped back to Bloomington where it was buried in the Deutsch family plot in Evergreen Cemetery.

Scope and Contents Notes

The Minnie Saltzman Stevens Papers consists of personal and legal papers belonging to the noted Bloomington-born Wagnerian soprano. The bulk of the collection contains correspondence between Madam Stevens and her attorney and executor of her estate, Joseph F. Bohrer. There is also correspondence between Madame Stevens and her good friend, Florence Fifer Bohrer; financial records; Italian death certificates; her will and probate documents; legal documents concerning her suit against Columbia Pictures; a book about the Covent Garden Opera Company; and an autograph book from her girlhood. The collection was arranged by the donor, Joseph F. Bohrer, upon his retirement in 1985, and relates to the Minnie Saltzman-Stevens papers at Illinois State University's archives.

Throughout her residence in Milan, Italy, Minnie kept in close contact with her attorney, Joseph F. Bohrer, the son of her close lifelong friend, Florence Fifer Bohrer, who acted as her proxy in financial transactions and was executor of her estate. Most of the material in the collection documents her relationship with the Bohrers from 1942 to 1950, or involves the settling of her estate (1950-1951).

Saltzman Stevens-Bohrer Correspondence and Papers covers the period between October, 1941 to September, 1949, and deals primarily with financial transfers to Minnie during World War II, various troubles in post-war Italy, and the drawing up of her will. There are also letters to Florence Fifer Bohrer, a letter dated November I, 1936, describing Saltzman Stevens' interest in and the start of her singing career, and personal notes to Joseph Bohrer.

Legal correspondence covers the period between September, 1946 and December 1949, and includes correspondence regarding her will and money to be sent to Italy, and correspondence from Bohrer to various stock corporations, banks, law firms, and the State Department, as well as early will drafts.

Receipts cover the period June, 1948 to July, 1950, and includes safety deposit box rental, income tax services, repairs to the Saltzman home in Bloomington, and stock receipts.

Minnie Saltzman Stevens vs. Columbia (1948) involves correspondence between Saltzman Stevens, Bohrer, and two other law firms (O.P.Westervelt in Peoria and George Link in New York) regarding a lawsuit against Columbia Pictures for unauthorized use of Saltzman Stevens' photograph.

Financial records from January, 1943, to June, 1952, include lists of Saltzman Stevens' stock holdings, correspondence from Bohrer concerning finances, lease agreements, and income tax forms (1943-1950).

State Department Correspondence includes letters and telegrams from Bohrer to the Federal Reserve Bank in Chicago, the Chase National Bank in New York, and the State Department during World War II.

Death Certificates filed in Italy in 1950 and four folders of Estate Files from December, 1948 to October, 1951, include communications, guardianship for Saltzman Stevens' heirs, announcements in the *Pantagraph*, inventories of personal effects shipped from Italy, Probate Court Petitions, and the Executor's Final Report.

Miscellany includes a letter from Minnie to one of her heirs, Arthur Worth Taylor, two letters in Italian, various affidavits, and financial records, and an envelope on which Bohrer made various notes.

The collection also contains a book, "Stories of the Operas and The Singers" (1910), which has a brief biography of Saltzman Stevens, and autograph book dating ca. 1890-1899, and a financial ledger.

Additional material on the Saltzman Stevens families, including obituaries, a concert program the Chatterton Opera House in Bloomington, II., and a letter from MSS to Edith Beyer, a Bloomington teacher, can be found in the opera book and the Photograph Collection.
