Brief History

Glen Wallace was an employee of Mitsubishi Motors North America, Inc. (MMNA) for more than twenty-five years. Wallace moved to Normal in 1989 from Bensenville, IL, after being hired at the automotive plant. He was employed as a welder in the body shop after a six-month hiring process. He worked in the body shop for ten years before transferring to the paint shop, where he remained until 2016 when MMNA officially closed. During his twenty-seven years at the plant, Wallace was a United Automobile Workers (UAW) Local 2488 union member, the first and only union to have an agreement with a foreign automobile manufacturer in the United States. Prior to being referred to as MMNA, the Midwestern automobile plant was known as Diamond-Star Motors (DSM), a joint venture between Mitsubishi and Chrysler. This joint venture allowed for UAW Local 2488 to be the representative of employees through its relations with Chrysler. The company opened in Normal, Illinois in 1988 and was McLean County's fifth largest employer, manufacturing automobiles for both the American and export markets (nations such as Canada, Mexico, Russia, and Spain). In 1991, Mitsubishi bought out Chrysler's interest and the operation's name was changed to Mitsubishi Motors Manufacturing of America (MMMA) and eventually MMNA.

Scope

The collection includes Glen Wallace's personal hiring records at DSM, employee benefit plans, UAW information packets and booklets, memos regarding changes and adjustment to benefits, workplace conduct policies, employee handbooks, employee training manuals, agreements between manufacturers and unions, memos regarding agreements between the manufacturer and UAW Local 2488, Mitsubishi publications and articles, and miscellaneous items.
