## Brief History

Irving “Irv” Tick (1928-2011) and Joan “Jobie” Marie (Sayler) Tick (1929-2021) were both longtime residents of Bloomington, engaged in many aspects of the community. Irv, a graduate of University High School in Normal, attended University of California at Los Angeles (UCLA). Upon graduation he moved to Chicago to work at the Board of Trade, before returning to his hometown permanently to help his father run the family business, Morris Tick Company, Inc.

Jobie also graduated from University High School and attended Illinois Wesleyan University in Bloomington. The couple wed in 1957, a union that brought forward two children, David Tick and Suzanne “Suzi” Tick.

Irv promoted equal opportunity as a member of the Bloomington Human Relations Commission, served on the Moses Montifiore Temple Board, and was an avid sketcher and painter. Jobie was the president of Community Players Theatre and ran for the 7th District County Board in 1978.

## Scope

The collection includes personal documents and memorabilia of Irv and Jobie (Sayler) Tick, the Irving Tick Art Event, Jobie’s childhood records, Annette Sayler’s Art Clippings, the Lyle Sayler Estate, David Tick, Suzanne Tick, Irving and Jobie marriage, Morris Tick Co., Loans Appraisals Insurance and Security, Cards, Letters and Notes, Funeral Cards, Address Books, Dairies, David’s Bar Mitzvah Photo Album and Family Histories.
